### CODE OF CONDUCT - TWIN PORTS PDC 2024

Parent/Guardian on behalf of Parent/Guardian personally and Participant acknowledges that The LLC has a zero tolerance policy with respect to uncontrollable behavior, bullying, hazing, alcohol, tobacco, drugs and controlled substances, weapons of any kind or any other activity which The LLC deems illegal or not in conformance with civilized standards of conduct and agrees to abide by this zero tolerance policy for the safety of all participants, guests, and employees. In connection with the above policy, Parent/Guardian grant The LLC the right to inspect any and all personal belongings of the Participant at any time on or off The Camp's location. Any consequences that come as a result of violating this policy are at the sole determination of The LLC and any dismissal from The Camp due to a policy violation will not result in a refund.

## WAIVER AND RELEASE FROM LIABILITY

This is an important, legal document. READ THIS ENTIRELY before signing. Signing this document is significant because you are waiving the right to make a claim against or sue Twin Ports Pro Development Camp LLC [The Camp] under certain circumstances. This agreement waives and releases The Camp from liability for negligent acts of its owners, directors, employees, volunteers, agents and their successors or assigns. This waiver is applicable to the participant, his or her parents, guardians, personal representative(s), executor, heirs, successors and assigns. HOCKEY IS A DANGEROUS CONTACT SPORT. It involves physical contact and exposes participants to various potential dangers.

THIS WAIVER, AND RELEASE AGREEMENT APPLIES TO injury, death or property damage that occurs as part of the normal risks of playing hockey, as well as injury, death or property damage resulting from the negligent acts of The Camp. These risks include:

- Injury, death or property damage caused by participation with other camp attendees including bigger, faster and stronger camp attendees;
- Injury, death, or damage to property that cannot be avoided regardless of the great care taken by The Camp to prevent or minimize the injury, death or damage.
- Injury, death or property damage arising from the inherent danger and foreseeable risks of pucks, sticks, skates, goal nets, ice, training equipment such as cones, boards, and arena glass that may occur at the facility where the camp is held including the ice surface, lobby, and locker-room areas.
- Property Damage includes property that may be lost, stolen, or damaged as a result of the typical and foreseeable risks of playing hockey

WHAT YOU ARE NOT WAIVING OR RELEASING. You are NOT waiving or releasing any claim against The Camp for injuries, death or damages arising from the reckless or intentional conduct of The Camp, its owners, employees, volunteers, agents, successors or assigns.

NOTICE REGARDING RECREATIONAL IMMUNITY. An appreciation of risk and responsibility of participants in recreational activities which includes practice, instruction, and play of hockey. The statute may limit your ability to hold The Camp or other Camp participants liable in the event of injury, death or damage to property.

YOU MAY BARGAIN FOR SOMETHING DIFFERENT. This form asks you to waive and release the right to make claims for injuries and damages caused by the negligence of The Camp. You have the right to bargain for a different type of waiver and release or for no waiver and release at all. If you want to bargain, contact Twin Ports Pro Development Camp, LLC at 1514 E 10<sup>th</sup> Street; Superior, WI 54880. **By signing this form you acknowledge that you have the right to bargain for different terms and have executed that right.**
